

2016 STATISTICS

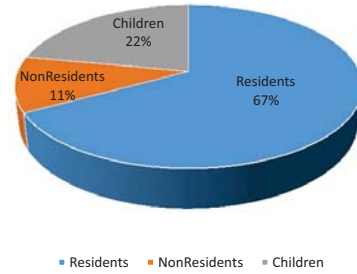
- In 2016, 14 single mother households with 23 children were housed at the Midland Fair Havens apartment complex. Within a nurturing Christian environment, these residents not only received safe & stable housing but they also benefited from case management, life skills training including financial management, counseling and education opportunities.
- As part of the Residential Program services in 2016, Fair Havens provided: 681 case management meetings, 125 Life Skills training hours, \$12,980 for tuition & books for college, 121 individual professional counseling sessions, 367 food boxes and 10,033 bed nights for women and children.
- These 14 Residents completed 249 college hours with a 94% (233/249) passing rate. 65% of these women are "First Generation" College students.

- Graduates: (1) BS in Nursing and (1) BA in Business Hospital Administration and (1) Associates Degree in Alcohol Drug Abuse Counseling.
- A Record 691 Families with 1365 children contacted MFH for Non-Residential services that included counsel & guidance, financial assistance to prevent homelessness, basic needs assistance and relevant referral to other agencies, an increase of 21% from 2015. Through follow-up, about 73% reported that the counsel and personal referrals that they received from Fair Havens were helpful in alleviating their family needs.
- 54 Non-Residential Single Mother Families (123 children) were assisted with over \$20,000 to prevent homelessness. These families received financial guidance in budgeting to equip them for improved fiscal stability.

RESIDENTIAL TRANSITIONAL PROGRAM provides:

- Rent-free, safe & secure housing for up to 24 months
- Individual Case Management for consistent emotional support & accountability to personal goals
- Life Skills Training in the areas of Finance, Parenting, Relationships, Bible study and more
- Individual Counseling to uncover root issues so that healing can take place
- Individual Assistance with Referral & Coordination with community resources for education, vocation development, and family health
- Children's Services including tutoring, individual counseling and junior life skills training.

Breakdown of Program Costs



NON-RESIDENTIAL PROGRAM provides:

- Individual Needs Assessment with Information & Referral Assistance to coordinate with community based resources needed to stabilize a family in crisis
- Financial Assistance with rent and utilities to prevent homelessness, includes basic budgeting advice and counsel for the family
- Basic Needs Assistance with food, clothing, etc.

CHILDREN'S ENRICHMENT PROGRAM for residential & non-residential children of single mothers provides:

- After School Tutoring through personalized, 'one-to-one' sessions
- 'Junior' Life Skills training to equip children for success in life
- Life Enrichment Activities to expand social experiences



Generational Impact

At Midland Fair Havens, we seek to build a brighter future for families. Not only is the single mother of the household equipped with skills to help her achieve self-sufficiency, the children are empowered as well. Adamaris' family came into the program when she was 8 years old. Hindered by a language barrier, she was struggling in school so we immediately began tutoring and assisting her mother with navigating the public school system. Through hard work, her grades improved and she began excelling in school. When the family left the program after two years, Adamaris continued to participate in our 'after school' tutoring program. Now as a freshman in high school, Adamaris is returning to volunteer as a tutor for our current families! Additionally, through the impact of her development as a student, Adamaris competed for and was accepted into the academically rigorous MISD Early College High School program where she will graduate with a high school diploma and an Associate's Degree from Midland College at the same time. Adamaris' achievements are a testimony that the MFH program is having a generational impact with endless possibilities for the future!

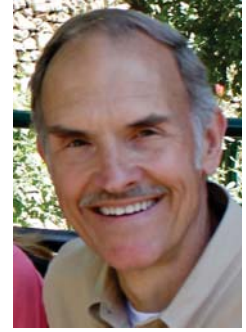
